Is this a new or existing strategy /policy/project	A new Joint Local Plan that will replace the two existing district local plans.
Aims and objectives of the Strategy/Policy/Service	The Joint Local Plan will contain policies that will help to guide planning application decisions for the districts relating to the development of land. Policies are also used to make planning decisions on enforcement and appeals.
	Some policies may be place-specific, for example, policies that allocate land for specified types of development (e.g., housing, employment, retail, mixed uses). Some policies may also protect assets or areas of land through designations (e.g., Green Belt or local wildlife sites). The Joint Local Plan may also contain

	generic polices including those promoting good design and protecting local shops, policies that set standards such as minimum home sizes and affordable housing percentages. These policies will influence development across the whole of the two districts.
	There are several preparation stages for the Joint Local Plan. The current stage is the first public consultation on the issues for the Joint Local Plan to consider. The aim is to get public feedback on suggested issues that could be considered as part of the Joint Local Plan, as well as get suggestions for new ones. A draft vision and set of opportunities have also been set out for feedback. The issues, vision and opportunities form the initial consultation and do not, at this stage, propose changes to existing policies.
	When new or amended policies are proposed through the later stages of the Joint Local Plan, then an EIA will need to be completed.
Who are the customer groups/staff affected?	All residents, businesses and any other stakeholders that work, travel and visit the districts.
Will there be any effect on other Council procedures or strategies?	Not as a direct result of this initial consultation.
	In its final form, the new Joint Local Plan may have an effect on other strategies such as: Homelessness and Rough Sleeping Strategy, Economic Development Strategy and the Active Community Strategy.
