

# Public GIS South

This is a useful tool for searching interactively for any enforcement action on S106 legal agreements obligations and for information about the Community Infrastructure Levy (CIL). It is also a tool for CON29 requests.

Click layers icon top right corner of the map:

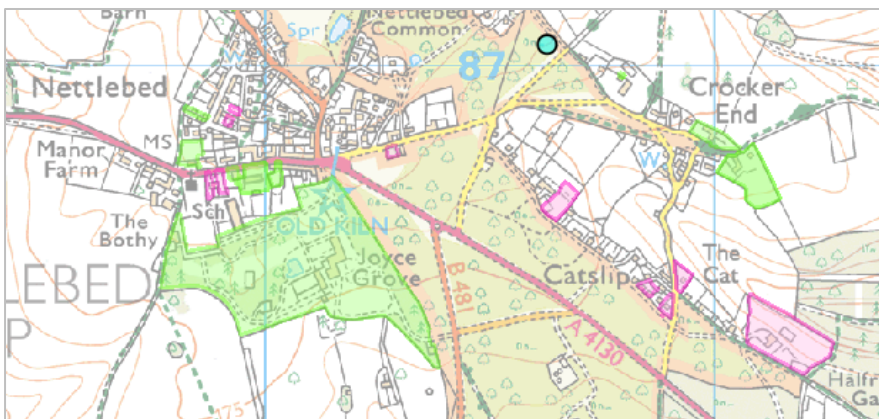


Click the eye and the on/off toggle for CIL notices or Planning Legal Agreements (whichever is needed):

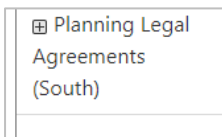

CIL notices show as pink shapes on the map, legal agreements as green:

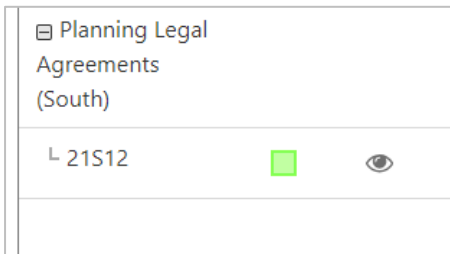


## For legal agreements

Click on an area and expand the planning legal agreements on the right by clicking the +



The agreements available will open:



Click on the one you want and hit the OK box that appears over the map:





A summary box will appear saying YES/NO to enforcement action for legal agreements.

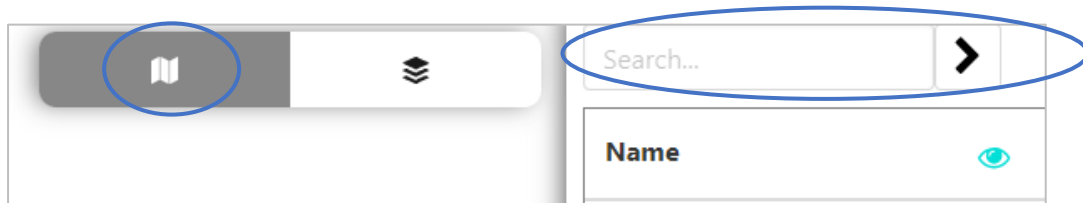

## Searching an address

For a specific address repeat as above, click on the layers icon  and then the eye symbol and the on/off toggle for CIL notices or Planning Legal Agreements:

Then click on the map icon  at the top, type the address in the search box and click the arrow:

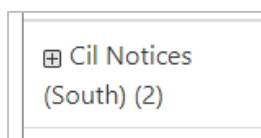






This will reveal any information for the layers selected and, as above, expand on the results by clicking the +. Select the resultant site you want.

A pop-up box may appear over the map, click OK.

## For CIL notices

Click in the relevant pink box on the map and expand the CIL Notices on the right by clicking the +, and subsequently on the relevant four-digit CIL reference.

Click OK on the pop-up to view the CIL Notice information in a new window.

The table will show the CIL and associated planning reference, the amount, location and any discount, **as well as CON29 3.10 (b) (i-vi) and (c) to (h) results**. If fully discounted this would normally mean self-build relief has been applied. Completion indicates the case is closed. (Please note if social housing discount has been applied the completion date will not show until the 7-year clawback period has ended). You may also search by address using the instructions above.
