Aims and objectives of the Strategy/Policy/Service	Vale of White Horse District Council have commissioned Stuart Todd Associates to produce a Leisure Playing Pitch Strategy (PPS). Stuart Todd Associates have now prepared a final draft PPS which includes changed post public consultation (in early 2024)			
	The PPS provides an audit of the quality, quantity, and accessibility of playing pitches in the district, and assesses the current supply, demand, and future demand. The draft PPS proceeds to makes recommendations on measures to protect and enhance existing facilities and to provide new facilities.

	The PPS identifies the following vision:
	"Our vision for the Strategy is that Vale of White Horse should provide a good supply of well managed and maintained leisure and recreation facilities, which are fit for purpose, meet identified needs and encourage all residents to take part in sport and physical activity.
	There will be a positive reaction to the impacts of climate change through sports provision, seeking to contribute to opportunities for the community to access sports facilities and ancillary facilities without the need to use unsustainable forms of transport to access facilities and support access to the facilities through active travel means. The strategy will support the Councils' vision to become carbon neutral by 2030 and to reduce emissions across the district."
	Once adopted, the PPS will replace the existing "Vale of White Horse Playing Pitch Study (October 2015)". At which point, the strategy will be used to inform planning applications, infrastructure applications and CIL spending.
